Obtaining consent, verbal or written. Refer to the ACA Code of Ethics or the current HIPAA laws, and the policies of your organization or agency.

Distance counseling (ND counselor and ND resident) and distance supervision are acceptable, but must be done under HIPAA compliance, using HIPAA compliant/secure formats. Audio communication

(phone) is acceptable. Refer to the policies of your agency or organization and HIPAA guidelines.
